## **Capacity**

Sit down dining: 25 - 46 (dependant on bridal table requirements)

Cocktail Party: 40 - 80

\*Children do not count towards minimum number requirements unless as a full paying guest.

## **Confirmation & Deposit**

You can make a tentative booking for your preferred date and we will endeavour to hold this for you for up to 14 days.

Bookings are not confirmed until a \$500 deposit and signed contract are received by CocknBull Boutique Hotel.

This deposit will be allocated towards the total cost of your wedding at the CocknBull Boutique Hotel.

## **Live music and DJ's**

If you wish to have live music or a DJ all accommodation must be booked. There is a 2 night minimum on all rooms from 1st September to 30th April. Under our council permit zone, music must cease at 11:00pm. After this time the CocknBull will provide light music through their sound system. Noise levels throughout the reception must comply with house regulations.

## **Reception Duration**

Your reception duration will conclude at 11:30pm or no more than 7 hours from commencement, whichever comes first.

## **Final Numbers**

The confirmed final numbers are required no later than 14 days prior to the function date. This refers to the total number of adults & children attending the event and is the number the CocknBull will cater & charge for. If the actual numbers exceed that confirmed, the additional guest/s will be charged at the same price per person.

## **Final payment**

Payment of the final account (food included) is due 7 days prior to the event. If beverages are on a consumption basis, the account must be paid on conclusion of function or the next day. Please be advised that credit card payments incur a 1.0% service fee. The CocknBull recommends payment by cash or electronic funds transfer.

To help ensure that your wedding reception is a success we provide you with our terms and conditions. To book and confirm your function, please sign below and return this form with your booking deposit.

## TERMS AND CONDITIONS

A booking deposit of \$500.00 and this signed form is required to confirm your reservation. Both payment and form need to be received in order for your booking to be secured.

Confirmation of final numbers and food selection is required 14 days prior to your function. These final numbers will be the numbers billed even if there are late cancellations.

Payment of the wedding package and food will be settled 7 days prior, and bar account at the conclusion of your evening. Please be advised that credit card payments (not Eftpos) incur a service fee of 1.5%.

If you wish to have live music or a DJ all accommodation must be booked. There is a 2 night minimum on all rooms from 1<sup>st</sup> September to 30<sup>th</sup> April. Under our council permit zone, music must cease at 11:00pm. After this time the CocknBull will provide light music through their sound system. Noise levels throughout the reception must comply with house regulations.

Any cancellation must be in writing. Booking deposits are non-refundable. Any cancellation within 30 days of wedding date will incur the full package charge.

For accommodation: any cancellation received within 30 days prior to arrival will incur the full period charge.

Any other hire requirements are at the clients cost. The CocknBull will not be responsible for damages or loss of property left on the premises prior to, during or after the function.

Any damage to our premises caused by guests is to be compensated by you.

Public Holidays will incur a surcharge and all accommodation must be booked. Minimum nights apply.
